The **Agricultural Tariff – Reduced Agricultural Tariff**¹ is a variable rate product, exclusively designed for agricultural holdings engaged in or contributing to, in any way whatsoever, the production of primary crop and livestock products, in accordance with those provided for in the JMD 142196/10-11-87 on "Measures for Rural Electrification".

Clarifications

- Where EFT = the state Energy Transition Fund
- The **Agricultural Tariff** is granted upon application by the interested party to the Administration of Agricultural Economy and Veterinary Medicine of the competent Regional Unit, which is competent for the collection and control of the necessary supporting documents for the electrification of agricultural holdings. If at any time the initial agricultural activity is modified, the Agricultural Tariff shall no longer be applied.
- Under the **Agricultural Tariff**, the charge for the energy consumed (€ per kWh) remains fixed regardless of the level of consumption. The amount of the fixed fee is in all cases calculated proportionally, by using the coefficient A = number of billing days /30.

- Based on the legislative framework as in force, PPC along with the electricity bills also collects various duties and taxes [VAT, Excise Duty (ΕΦΚ) and Special Duty 5%] and fees payable to third parties [Municipal Duties (ΔΤ), Municipal Taxes (ΔΦ), ERT fee (the Hellenic Broadcasting Corporation), Real Estate Municipal Duty (ΤΑΠ)], as defined by the State.

Regulated Charges²

The Regulated Charges are approved by the State and apply to all customers using the National Electricity System, irrespective of the supplier they have chosen.
